**APPLICATION FOR RELIEF FOR THE ADMISSION OF  
KATHRYN KENEALLY *PRO HAC VICE***

Teresa D. Miller, in her capacity as statutory rehabilitator (“Rehabilitator”) of Penn Treaty Network America Insurance Company and American Network Insurance Company, hereby moves this Court pursuant to Rule 301 of the Pennsylvania Bar Admission Rules and Rule 1012.1 of the Pennsylvania Rules of Civil Procedure, to specially admit Kathryn Keneally, Esquire to the bar of this Commonwealth for purposes limited to the above-captioned matters and to appear and practice before this Court in all proceedings as her counsel, and in support thereof, aver as follows:

1. Jayne A. Risk, who is a member of the bar of the Commonwealth of Pennsylvania, hereby moves for the admission, *pro hac vice*, of Kathryn Keneally, Esquire.

7. The information required by 204 PA. CODE § 81.504 has been provided to the IOLTA Board. *See* Pennsylvania IOLTA Board Form for *pro hac vice* Admission, attached hereto as Exhibit D.

WHEREFORE, the Rehabilitator. respectfully requests that this Court admit Kathryn Keneally. *pro hac vice* pursuant to Rule 301 of the Pennsylvania Bar Admission Rules.
