AND NOW, this 22nd day of March, 2019, upon consideration of the Application for Limited Intervention of Aetna Life Insurance Company, Anthem, Inc., Cigna Corporation, HM Life Insurance Company, Horizon Healthcare Services, Inc. d/b/a Horizon Blue Cross Blue Shield of New Jersey, QCC Insurance Company, United Concordia Life and Health Insurance Company, United Concordia Insurance Company and UnitedHealthcare Insurance Company (collectively, Health Insurers), and the answer of the Insurance Commissioner, in her capacity as Statutory Liquidator of Penn Treaty Network America Insurance Company (In Liquidation) and American Network Insurance Company (In Liquidation) (collectively, the Companies), it is ORDERED that the Application is GRANTED.

Pursuant to Pa. R.A.P. 3775, Health Insurers are granted limited intervention to participate in the above-captioned matter on the issue of the Liquidator's proposed allocation of estate assets to pay policyholder benefits that exceed applicable guaranty association limits and which accrued more than 30 days after the Court's order of March 1, 2017, placing the Companies into liquidation. In lieu of docketing the Application for Determination of Authority appended to Health Insurers' Application for Limited Intervention, Health Insurers are directed to file a response to the Liquidator's Application for Declaration Regarding Policyholder Claims for Non-GA Policy Benefits by April 22, 2019.
